

Conditions of Entry: Admission to Events: Additional COVID-19 Amendments

Prohibited Items and bags Restrictions:

1. The only bags permitted to be brought into the MCG must be equivalent to, or smaller than, A4 size (30 x 30cm), clear bags or baby bags which are small enough to fit under the patron's seat. No backpacks and sports bags of any size are permitted (including, small backpacks and handbags that can be worn as backpacks).
2. Due to current COVID-19 restrictions, cloakroom will not be offered at the MCG at this event.

Patron Behaviour:

1. By purchasing or accepting tickets to the MCG, each patron acknowledges that, even with rigorous control measures in place at the MCG, there remains an unquantifiable risk of transmission of viral illness, including COVID-19.
2. By attending the MCG, each patron acknowledges that they have considered the health risks associated with their own personal circumstances, including any health condition or vulnerability that the patron may have, and the circumstances of persons with whom patrons may potentially be in close contact following attending the MCG.
3. Patrons acknowledge that, for some groups of people, COVID-19 has very serious health consequences.
4. The MCC expressly relies on patrons to bring the health issue waiver (as described in paragraphs 1-3 above) to the attention of any guest(s) of the patron. The MCC will rely on this health issue waiver and proceed on the basis that all patrons who attend the MCG acknowledge and accept these risks.
5. If a patron is feeling unwell, currently has any of the possible symptoms of COVID-19, has travelled overseas in the past 14 days, or has been in contact with a confirmed COVID-19 case in the past 14 days, or has undertaken a COVID-19 test recently with results pending, that patron must not seek to obtain entry to the MCG.
6. The MCC strongly recommends that all patrons install the Australian Government COVIDSafe App on their mobile device, with Bluetooth activated prior to, and during, the patron's attendance at the MCG.
7. Ensuring the health and safety of the community is of the utmost importance. Patrons acknowledge that if a patron appears to be unwell and exhibits any symptoms of COVID-19, or any other symptoms that may place persons at risk, or endanger or impact public health, that patron will be refused entry to, or may be evicted from, the MCG immediately by an Authorised Person.
8. Patrons must adhere to the following COVID Safe requirements while attending the MCG:
 - a. practise physical distancing, where you can stay at least 1.5m away from others;
 - b. wear a face mask in accordance with the requirements and directions issued by the Victorian Government and / or the Chief Health Officer;
 - c. follow signage, row in the designated seat on the patron's ticket, and only move around within the zone designated on the patron's ticket to use the amenities including food and beverage outlets;
 - d. implement hygiene practice and process (including washing hands or using hand sanitiser regularly – hand sanitiser will be available at the MCG);
 - e. cough or sneeze into your elbow and dispose of tissues responsibly; and
 - f. comply with any health directions issued by the Victoria Government and / or the Chief Health Officer's in regards to COVID-19.
9. Patrons must remain in their ticketed seat at all times unless they are:
 - a. moving to their seat as part of ingress;

- b. leaving their seat to egress the MCG; or
- c. moving to use the amenities within the zone of the MCG specified on their ticket (for example, for the purpose of purchasing food or drink, using the bathroom, attending first aid).

Patrons acknowledge that any failure to adhere to the above requirements may result in that patron being refused entry to, or evicted from, the MCG.

10. Each patron authorises the MCC and / or the hirer to collect and store that patron's personal information and data, and share it at any time with relevant authorities for the purposes of contact tracing. This includes scanning of government contact tracing QR codes as required including upon entering the venue and other locations as mandated by the venue.
11. If a patron has a medical certificate exempting them from the health directions, please contact the MCC prior to the day of the event, so that MCC is able to confirm and facilitate that patron's entry to the MCG on the day.

Venue:

1. The MCG is operating as a 'cashless' venue during current COVID-19 restrictions. Please be advised that cash is not accepted throughout the MCG and the surrounding precinct, this includes food and beverage and merchandise outlets.
2. Patrons must not approach any player, performer or match official, and must stay at least 3 seating rows (1.5 metres) away from the arena, interchange bench, player dug out or player / official arena-race at all times.
3. The MCG has been split into five zones for contact tracing purposes. Each ticket identifies the zone of the MCG into which the patron is permitted to enter. Patrons must remain in the zone identified on their ticket and not cross into any other zone of the MCG.
