Acknowledgement of Country

The Melbourne Cricket Club (MCC) respectfully acknowledges the Wurundjeri Woi-wurrung people as the Traditional Owners of the land where our administration office is based within the Melbourne Cricket Ground (MCG) and where many of our members come together every week.

As an umbrella organisation for 14 Sporting Sections, we also acknowledge the Traditional Owners of the lands across Melbourne where our Club hosts and plays sport, the Bunurong / Boon Wurrung and Wurundjeri Woi-wurrung peoples of the Kulin Nation.

The land surrounding the MCG, now called Yarra Park, has been a special meeting place from time immemorial for Wurundjeri Woi-wurrung people, long before the stadium was built and it became a meeting place for modernday Australia. It was the place of age-old ceremonies of celebration, initiation and renewal. The MCG today is a place for newer ceremonies, many of which proudly involve First Nations peoples. Their living culture had and continues to have a unique role in the life of the MCG and its surrounding precinct.

The MCC recognises and respects the cultural heritage of Aboriginal and Torres Strait Islander peoples, their beliefs, their relationship with and connection to country, and the significance of the land where we are situated and where we invite millions of visitors each year.

We acknowledge that these beliefs and relationships are of continuing importance to Aboriginal and Torres Strait Islander peoples and should be celebrated. We pay our respect to the Elders past, present and emerging of the lands in which we operate.

PRESIDENT'S REPORT FRED OLDFIELD

Our Club has simply had an incredible year across the management of the iconic Melbourne Cricket Ground (MCG), our membership and heritage operations.

When we reflect on our place in the community and the wider Australian landscape, I'm often reminded how our collective efforts truly shape the enjoyment of others through the vehicle of sport. Our members, staff, contractors and volunteers - the people who are at the stadium every day - are truly the beating heart of a place that is so renowned locally, nationally and globally.

It has been an exceptional financial year for the Melbourne Cricket Club, with many MCG highlights including:

- record attendances achieved across the 2023 AFL Premiership Season and first rounds of 2024
- · a successful and competitive Boxing Day Test Match
- three sold-out concerts as part of Taylor Swift's | The Eras Tour.

In a year where we have welcomed more than four million members and patrons through the gates for a major event day, an MCG Tour, a function or to visit one of our museums, the 'G has been one of the most attended stadiums in the world and the centrepiece of entertainment in our state.

From a Club perspective, we have held our regular and well-attended

member functions including the Norm Smith Oration, the Bradman Lunch, the Brownlow Dinner (featuring the Coodabeen Champions), Members' Dinner and the Boxing Day Test breakfasts. The quality of speakers at these functions is a testament to the standing these occasions have in Australian sport, created exclusively for our members.

We have expanded our functions program this year to give our members more opportunities to interact and enjoy each other's company. Using the renovated Trumble Bar and Café, we have hosted viewing functions for the Matilda's World Cup games and the 2023 AFL Preliminary Finals. We also implemented a Progressive Dinner, where members enjoyed courses in different areas across the Reserve, and a Christmas Chocolate Masterclass, both of which were roaring successes.

Another notable event was the new 50-Year Member lunches, where the first intake of female members attended.

Our special interest groups, of which we have six, continue to thrive within Club life. A highlight of one of our groups - the Long Room Wine and Food Society - was a lunch hosted in August attended by more than 250 members. They enjoyed wine provided by Ponting Wines - co-founded by former Australian Test captain Ricky

Ponting - paired with a First Nationsinspired menu developed by one of our on-site chefs, Luke Bowden.

The Club has conducted a membership review over the past few years, which included surveying our members and holding focus groups to fully understand what you enjoy and opportunities for improvements. The Club continues to invest in facilities to ensure the Members' Reserve - and the whole MCG - remains world class and reflects the desires of contemporary patrons. Investment in dining facilities in the Members' Reserve has resulted in the opening of Missymu by Shirley and updated menu offerings across the Members' Dining Room, Jim Stynes Grill and the Committee Room by Grossi.



During 2023/24, the Melbourne Cricket Club (MCC) Library has been celebrating its 150th year. While some may still describe it as a hidden gem, our Library is regarded as having a preeminent collection of sporting books. It is often visited by some of your favourite commentators ahead of the Boxing Day Test or journalists throughout the AFL Premiership Season to gather important statistics or facts ahead

While the Australian Sports Museum (ASM) officially reopened in February 2020 following an extensive renovation, it remains a new experience for many. Just over 175,000 people visited the museum in this financial year.



Celebrating the history and impact of sport in Australian culture with many opportunities to discover and play in the space, the success of the ASM and MCG Tours is built on the countless hours dedicated by our team and volunteers. In the MCC Museum, which adjoins the ASM, a new exhibition was opened in February 2024 documenting the introduction of women into our membership in the 1980s.

Sporting sections

Our sporting sections, which boast more than 3,000 participants, claimed premierships in hockey, bowls, cricket, netball, squash and tennis. It's a remarkable effort that cements sport at our core. In a special feat, the Melbourne Football Club - another of our sporting sections - won the revamped McClelland Trophy incorporating results across both the men's and women's competitions.

There were enjoyable sporting tours to our reciprocal international clubs, with visits to the Marylebone Cricket Club in London and The Royal Bangkok Sports Club in Thailand. A members' tour of Europe and England coincided with the 2023 Ashes Test Match played at the Lord's Cricket Ground. The tour received many positive reviews, which has encouraged us to investigate other touring opportunities.



Philanthropy

The MCC Foundation, our philanthropic arm, continues to make a significant contribution to the community by removing barriers to participating in sport. Adding to our stable of partners this year, we supported Cricket Australia in reviving the National Indigenous Cricket Championships.

CEO'S REPORT STUART FOX

The Club, the MCG and the Australian Sports Museum remain cemented in the hearts and minds of Victorians and Australians, with record attendances achieved in 2023/24 across our operations and success measures being met within our five-year strategic plan.

Unforgettable experiences

What an unforgettable moment for Melbourne and the 'G, with more than 288,000 people witnessing history being made as Taylor Swift performed to her largest-ever crowd of 96,000 for three consecutive nights. This remarkable feat is equivalent to hosting three AFL grand finals in a row.

These shows, 18 months in the making, delivered beyond expectations. A heartfelt thank you to the incredible Swifties who showed up in spectacular, creative costumes and created the most electrifying atmosphere each night.



We also extend our gratitude to the dedicated staff who worked tirelessly to ensure the safety and seamless experience for all ticket holders at our world-class stadium.

These concerts marked a truly iconic moment in the MCG's storied history and cemented an enduring love story between Melbourne, Taylor Swift and her devoted fans.

The Club also wishes to acknowledge the ongoing support from HG Sports Turf, which completed the MCG's second-largest turf replacement following these concerts – making it the largest transformation in size since a full field of play replacement in 2014 where 18,000m² of turf was replaced.

We also could not have done this without our talented Arenas team, which works

tirelessly throughout the year to ensure each event runs seamlessly – coordinating the transition from an AFL ground to rugby pitch, cricket oval and concert venue with scarce breaks in between.

Big crowds, impactful moments and a Grand Final to remember headlined the AFL fixture at the MCG across 2023 and early 2024, with the 2023 Premiership Season and Finals Series smashing the previous record for attendance at the MCG. A total of 3,319,002 fans attended the MCG for football in 2023, the largest of any AFL/VFL season ever.

The traditional ANZAC Day match between Collingwood and Essendon achieved the highest-ever attendance for an ANZAC Day match, with a crowd of 95,179 witnessing the Pies defeat the Bombers by 13 points.

A record crowd was also present for another special MCG match almost two months later, with the Big Freeze at the 'G - held on King's Birthday - achieving its highest attendance with 83,578 fans packing the ground.

The 2023/24 cricket season highlighted a strong sense of community and connection through various significant fixtures. In November 2023, the MCG hosted the first Women's Big Bash League (WBBL) Melbourne derby and the inaugural women's Premier Cricket match, celebrating the achievements of Australia's women's sporting teams.

Building on the success of the ICC Women's T20 World Cup in 2020, Cricket Australia announced that Australia will face England in the Women's Ashes Series from January 30 to February 2, 2025, marking the first Women's Test at the MCG since 1949 and the first day/night Test at the stadium.

The 2023 Boxing Day Test between Australia and Pakistan was another highlight. Despite grey skies and interruptions on Day 1, 62,167 fans attended, with a total of 164,835 fans over the four days of play. Australia, led by captain Pat Cummins, claimed a 79-run win in a competitive match, adding to the MCG's legacy of iconic cricketing moments

World-class stadium and precinct

The Club continues to invest in the MCG and the precinct and this year has continued to draft the Yarra Park masterplan for the future maintenance and development of Yarra Park.

As outlined in last year's report, the Club undertook a feasibility study to better understand the future of the Shane Warne Stand. This work is still ongoing with no determinations made yet.

The Australian Sports Museum proudly reached a new visitation milestone in early 2024, with more than 175,000 people exploring the museum and taking part in an MCG Tour over the past year.



In keeping with the venue's ongoing commitment to provide an inclusive environment for all patrons, tours of the MCG have become more accessible for everyone with the addition of Auslaninterpreted tours, while a new dedicated 'Keepers' Collection Tour' has allowed visitors access to hidden sporting archives beneath the MCG.

What's new at the 'G

In the past year, there have been significant upgrades around the MCG to meet both demand and patron expectations of a world-class stadium.

On level 2 of the Olympic Stand, two new custom-built TV broadcast suites were completed just in time for round 1 of the 2024 AFL Premiership Season. As part of this development, the Betty Cuthbert Bar was relocated to the rear atrium space. The newly renovated area now offers a fresh, light-filled environment that can fit up to 300 patrons and has views of Yarra Park.



The Ponsford Atrium has also been transformed into a new bar and food outlet for patrons to enjoy on match days. Conveniently located near the Dean Jones Bar and Harrison Room, this bar can accommodate up to 350 patrons and offers views of the city skyline.

Both bars have already proven to be popular on match days and non-match days for corporate events and functions.

Additionally, Missymu by Shirley was launched at the beginning of the 2023/24 cricket season on level 3 of the Ponsford Stand, offering a shared dining experience that combines traditional Pan-Asian flavours with a contemporary twist.

Leadership in our DNA

The Club's commitment to reducing its carbon footprint is fundamental in maintaining the MCG's status as a worldclass stadium. For this financial year, we are proud to announce a landmark achievement in our sustainability journey. The MCC has become Australia's first sporting club to achieve Climate Active certification for its operations. This achievement recognises the Club's dedication to minimising emissions and investing in carbon offset projects. Achieving this certification reflects more than a decade of dedicated efforts in enhancing the Club's sustainability across various operational areas, such as energy use, waste management and water conservation.

We continue in our commitment to the national reconciliation movement. We have forged an even stronger relationship with the Wurundjeri Woi-wurrung Cultural Heritage Aboriginal Corporation (WWCHAC), which represents the Traditional Owners of the land on which the MCG is based. Several initiatives have taken place regarding the scarred trees located in Yarra Park.

The philanthropic arm of the Club, the MCC Foundation, aims to preserve Australian sporting history and enhance access to sport for all Australians. In this financial year, we have celebrated the hosting of the first training camp at the MCG following our first year in partnership with the National Indigenous Cricket Championships. It was an incredible moment for so many male and female players to have access to play on our iconic platform.

New technology

We were excited to introduce new cuttingedge technology at the MCG to enhance the stadium experience for patrons.

Evolv's touchless security screening technology has been fully installed at all gates, setting a new standard for stadium security in the southern hemisphere. The technology's ability to detect prohibited items ensures every patron undergoes the same level of security screening efficiently, preventing queues from building up.

All turnstiles have also been upgraded with NFC (Near Field Communication) technology, eliminating the need to scan barcodes or adjust phone brightness. Patrons can simply download their ticket from the Ticketek app to their digital wallet and 'tap-and-go' at the turnstiles. NFC provides greater security, with tickets encrypted and stored securely in the digital wallet on the device.

Patrons can also now purchase their favourite food and beverage items faster than before at our two new MCG Express outlets in the Ponsford Stand. Using AI, machine learning and sensor fusion technology, patrons can spend less time in the queue and more time in their seats.

Membership intake

Melbourne Cricket Club membership was 157,389 on August 31, 2023 (the last date of the 2022/23 membership subscription season), with 188,608 candidates on the waiting list.

Full members comprise 63,805 of the total membership base and include nominations to September 30, 1992.

Restricted members comprise 43,230 of the total membership base and include nominations to December 31, 1998.

Provisional members comprise 50,354 of the total membership base and include nominations to November 30, 2006.

Operating results

The Club recorded a net profit of \$32.102 million for the financial year ending March 31, 2024.

The remaining balance of \$37.03 million in debt in respect of the Northern Stand redevelopment was repaid in full during the financial year, more than two years in advance of the due date.

Treasurer Geoff Roberts will report the Club's financial results in detail at the 187th Annual General Meeting in August 2024.

Our Club

The Melbourne Cricket Club was established in 1838 by five people for recreation and socialising. Little did these pioneers know that they were sowing the seeds for a club that would grow to play a fundamental role in Australia's love of sport.



Founded on November 15, 1838, the Club played cricket on various Melbourne sites before settling on its current site, once known as a police paddock, in September 1853.

The Police Paddock, now known as Yarra Park, is anchored to its 65,000 year First Nations history and as ceremonial grounds for the Kulin Nation.

The MCC has always been the foremost promoter of sport in Australia. In 1859 the MCC drew up the first set of rules for Victorian (later Australian) Football. The Melbourne Cricket Ground (MCG) hosted the first tour by an English cricket team in 1862, the first Test match in 1877 and the first One-Day International match in 1971. It has also been home to the 1956 Summer Olympic Games, the 2006 Commonwealth Games, two ICC Men's One-Day International Cricket World Cups and one ICC Women's T20 World Cup.

Our history is one of boldness, adaptation and transformation; our future will be too. This has never been more important given the unprecedented changes taking place in our communities, our industry and the world.

Today, the MCC is a private club with public responsibilities. Its scope encompasses:

 managing the MCG as the world's greatest stadium on behalf of Victorians

- providing the best services and facilities for more than 150,000 members
- respecting the history of sport and its influence on Australia's culture through the management of the Australian Sports Museum, MCC Museum, MCC Library and MCG Tours
- maintaining Yarra Park as a public facility for every Victorian to enjoy
- the MCC Foundation, which aims
 to promote and enable access to
 sport and participation through
 the oversight of 14 Sporting Sections,
 partnerships with community
 organisations and management
 of our sporting grounds
 throughout Melbourne.

The Melbourne Cricket Club is the largest sporting club in Australia consisting of over 157,000 members and approximately 188,000 on the waitlist to join. There are three main levels of membership – Full, Restricted and Provisional – which entitle those members to varying benefits. One of the benefits includes access to the MCC Members' Reserve on event days at the MCG. The MCC Members' Reserve equates to 23 per cent of the total capacity of the MCG.

Today, the MCC is an umbrella organisation for thousands of participants in 13 sports (14 sections): baseball, bowls,

cricket, croquet, Australian Rules Football, golf, hockey, lacrosse, netball, real tennis, squash, target shooting and tennis. The Melbourne Football Club is also one of the Club's Sporting Sections.

The Club's principal public role however, remains the progressive management and development of one of the country's greatest assets – the MCG. The MCG has a global reach, holding a special place in the hearts and minds of all sport-loving Australians as well as many international visitors and guests. Each year the MCG plays host to many domestic and international cricket games, matches as part of the AFL Premiership Season and other special events and concerts. The MCC works closely with Cricket Australia, the AFL and concert/event promoters in bringing major events to the MCG.

Modern times have seen the MCC work with the MCG Trust, an independent board appointed by the Victorian Government to ensure the special place of the MCG is maintained, cherished and celebrated for generations of Victorians, Australians and international visitors to come.

Also managed by the MCC is Yarra Park, a traditional Kulin Nation meeting place that contains at least two scarred trees. The MCG is a modern-day meeting place located within Yarra Park, located on land of the oldest living culture in the world.



The MCG operates in conjunction with catering, cleaning and security partners, Delaware North, ISS and SecureCorp respectively, with another 3,000 staff members engaged on event days.


The MCC's philanthropic arm is the MCC Foundation which is a company limited by guarantee and not-for-profit entity. The MCC Foundation provides financial support to various community sport activities and programs. The Foundation encourages and promotes the playing of sports, through the provision of funds for the MCC's Sporting Sections and community partnerships. Current community partnerships include the Bachar Houli Foundation, Melbourne Indigenous Transition School, the Santa Teresa Oval Project, Sports Excellence Scholarship Fund, Western Bulldogs CALDplay program, National Indigenous Cricket Championships and Special Olympics Australia.

The MCC Foundation also invests in facilities and amenities for the use and enjoyment of members and the Sporting Sections. The MCC Foundation partnered with the Victorian Government to provide world-class sporting facilities at Beaumaris Secondary College, Elwood College and Melbourne High. The facilities are used by students during school hours and the MCC's Sporting Sections and other local community groups outside of school hours.

The MCC also oversees the management of the Australian Sports Museum, MCC Museum, MCC Library and MCG Tours based at the MCG. After recently undergoing an extensive \$17 million redevelopment, the Museum celebrates more than 90 different sports, the way sport is ingrained in Australian culture while also paying tribute to the sporting feats of First Nations peoples.



A RECORD-BREAKING YEAR OF AFL AT THE MCG

Big crowds, impactful moments and a Grand Final to remember headlined the AFL fixture at the MCG across 2023 and early 2024, with the 2023 Premiership Season and Finals Series smashing the previous record for attendance at the MCG. A total of 3,319,002 fans attended the MCG for football in 2023, the largest of any AFL/VFL season ever.

2023 AFL Premiership Season

Following a huge opening three rounds for the 2023 AFL Premiership Season, crowds continued to flock to the MCG as home clubs recorded high attendances and crucial wins in some of the biggest match-ups of the competition.

Across the first 10 matches of the season, the MCG welcomed 661,446 fans and members through the gates – surpassing the previous attendance record set for the same amount of games in 2015.

In Round 3 St Kilda hosted a rare MCG home game, celebrating its 150th anniversary in front of a crowd of 69,255 against the Bombers. The pre-match entertainment paid homage to the 1966 premiership team – winners of St Kilda's only VFL/AFL premiership.

With an MCG-bye in Round 5 as the entire league travelled to Adelaide for the inaugural Gather Round, crowds returned in droves for Round 6 and the ANZAC matches.

Paying their respects to past and present serving men and women, representatives from the MCC, including President Fred Oldfield, CEO Stuart Fox, Committee Representative for the Military Veterans' Group James Cain, and Chair of the Military Veterans' Group Roger Greene laid wreaths at the plaques inside Gate 2, which remained for the duration of the Round.

The traditional ANZAC Day match between Collingwood and Essendon saw the highest ever attendance for an ANZAC Day match, with a crowd of 95,179 witnessing the Pies defeat the Bombers by 13 points.

A record crowd was also recorded for another special MCG match almost two months later, with the Big Freeze at the 'G – held on King's Birthday – recording its highest attendance with 83,578 fans packing the MCG.



Fans of both Melbourne and Collingwood alike turned the MCG into a sea of blue Big Freeze beanies as 10 of Australia's much-loved stars took the plunge down the Big Freeze slide into the icy pool below – all in the name of raising funds for FightMND.

The total tally from the 2023 Big Freeze campaign was a record-breaking \$15,821,644.

The MCG also hosted the Breast Cancer Network Australia (BCNA) Pink Lady Match between Melbourne and Hawthorn during Round 23.

For the first time in five years, thousands united in the middle of the MCG to form the iconic Pink Lady silhouette – raising awareness for the work the BCNA does for those diagnosed with breast cancer.



Other marquee matches for the season included Dreamtime at the 'G as part of Sir Doug Nicholls Round, the ANZAC Day Eve match between Melbourne and Richmond and the introduction of a King's Birthday Eve rivalry clash between Carlton and Essendon.

2023 AFL Finals Series and Grand Final

The MCG hosted six matches throughout the 2023 AFL Finals Series – five of which saw crowds of more than 90,000 fans and MCC members enter through the turnstiles.

Week 1 of the Finals Series saw back-to-back crowds of over 92,000 on Thursday and Friday night as Collingwood took on Melbourne and Carlton hosted the Sydney Swans. The trio of matches that week saw the GWS GIANTS defeat St Kilda in front of 68,465 fans on the Saturday.

Crowds continued to grow for the next three weeks – 96,412 in attendance for the Semi-Final between Melbourne and Carlton, and 97,665 for the Preliminary Final between Collingwood and GWS, before maxing out for the biggest game of the season.

For the second year in a row, the MCG held a capacity crowd of 100,024 for the Grand Final, with the packed stadium enjoying the down-to-the-wire Grand Final between Collingwood and the Brisbane Lions.

KISS kicked off Grand Final Day with an epic pre-match performance, playing some of their classics and joined on the hallowed turf by hundreds of kids donned in KISS face paint and outfits.

The performance was followed by an Australian-inspired half-time performances featuring former Hunters & Collectors frontman Mark Seymour with his band Mark Seymour and the Undertow and special guest Kate Miller-Heidke.



One of the warmest Grand Final days in recent memory would also provide one of the most gripping Grand Final encounters – the first-half free-flowing and high scoring, and the second dominated by defensive pressure.

The classic Grand Final – touted as one of the best of the modern era – saw Collingwood finish with a four-point win and claim their 16th VFL/ AFL premiership, drawing equal first with Carlton and Essendon for most premierships won.

The Grand Final was the ultimate finish to an incredible season with new history made at the 'G.

2024 AFL Premiership Season

For the second year in a row, the MCG hosted four matches in Round 1 of the AFL Premiership Season.

With four matches already played in New South Wales and Queensland for the AFL's new initiative – Opening Round – the stakes were already high for many of the teams in action at the MCG in Round 1.

As usual, Carlton and Richmond opened the MCG season with a Thursday night blockbuster, whilst reigning premiers Collingwood unfurled their Premiership Flag on the Friday night against the Sydney Swans.

Round 2 saw St Kilda host a rare first home-and-away match at the MCG, as they took on Collingwood in Spud's Game – an annual fixture on St Kilda's calendar which raises funds and awareness for mental health

To the end of the 2023/24 Annual Reporting period – March 31, 2024 - the MCG had welcomed a total of 469,562 fans through the gates across eight matches – averaging 58,695 per match.

Old and new traditions connect generations of cricket fans at the 'G

The 2023/24 cricket season at the MCG was defined by a range of local, domestic and international fixtures imbued with significance – a sense of community and connection at the forefront of every fixture.

In November 2023, the decorated stories of past female cricketers formed the beginnings of a new narrative with the first Women's Big Bash League (WBBL) Melbourne derby held at the MCG, followed by the first ever women's Premier Cricket match at the venue.

This commitment to showcase and celebrate the achievements of Australia's women's sporting teams – especially after the success of the ICC Women's T20 World Cup in 2020 held at the MCG – has been strengthened by the recent announcement by Cricket Australia. It has confirmed that Australia will face England from January 30 – February 2, 2025 as part of the Women's Ashes Series in what will be the first women's Test held at the MCG since 1949 and the first ever day-night Test match held at the stadium.

The 2023 Boxing Day Test between Australia and Pakistan was another highly anticipated event to complete a huge year of grants at the MCG.

It was a gloomy start to the Test, with grey skies threatening to derail the first few days of play, but despite some interrupted play on Day 1, 62, 167 fans and members made their way to the MCG on Boxing Day for the opening day's play.



A total of 164,835 fans attended the Test over four days. Australia claimed a 79-run win over Pakistan in what was a largely even contest between bat and ball, with the home team emboldened by the efforts of captain Pat Cummins.

Cummins was awarded the Johnny Mullagh Medal for player of the match, with a ten wicket haul seeing his name added to the MCG honour boards once again.

With similar sentiment to the previous year, the Test allowed fans to pay homage to the late Shane Warne by wearing replicas of his favoured floppy hat. Preservation of Warne's legacy continued to build on the previous Test, this year taking a new direction – one that would potentially benefit the health of thousands of patrons who attended the Test.



An initiative between Cricket Australia and the Shane Warne Legacy saw heart tests provided by SiSU Health positioned in and around the venue, providing fans with an indication of any potential heart risk factors.

The MCG was once again home to the Melbourne Stars in the Big Bash competition, playing three fixtures across January including a Melbourne derby against the Renegades on January 2, 2024.

The Stars concluded their BBL|13 campaign with four wins and six losses to finish sixth on the BBL ladder. The summer of cricket at the 'G officially wrapped up with a One-Day International between Australia and the West Indies.

Upon formally honouring these two greats of the sport, Australian Cricket Hall of Fame Chair Peter King lauded the impact of both cricketers who made a significant imprint on the sport through unwavering commitment and leadership.

TURF TEAM RISES TO THE OCCASION

The MCG's diverse and growing event schedule has prompted global praise – a new era for our 170-year-old venue with events experienced by generations of fans at the beloved people's ground.

Fans, members and onlookers have recognised the venue's ability to successfully host an AFL season inclusive of finals, a full summer cricket schedule including the traditional Boxing Day Test, and one of the most anticipated concerts in recent memory.

The MCC arenas team has worked tirelessly over the past 12 months to ensure each event can run seamlessly - coordinating the transition from an AFL ground to rugby pitch, cricket oval, and concert venue - all with scarce breaks in between

The final weekend of July 2023 required a massive effort from the team with the MCG welcoming 223,023 patrons through the gates across two huge AFL matches either side of the opening test of the Bledisloe Cup.

The venue was primed for a massive crowd on the Friday night with Carlton taking on arch rival Collingwood, and moments after the final siren the arenas team began the process of removing the goal posts, markings and logos on the ground.

With an 18-hour window until the Wallabies faced the All Blacks on home soil, the rugby posts were installed, line markings were painted, and around 240 metres of LED signage was put into position ready for 83,944 fans to pack the MCG in what was the Wallabies' biggest home crowd in 20 years.

The arenas team was faced with an even smaller transition period of 15 hours to once again turn this all around in time for Richmond to take on Melbourne on the Sunday afternoon. By the conclusion of the weekend the total number of posts moved in and out of the arena came to 24.



The process of changing the playing arena to suit the different sporting codes is an immense responsibility while ensuring the ground is in pristine condition.

The works that occur during a transformation process include the physical task of removing goal posts, the movement of drop in cricket pitches and the intricate changes to the field of acknowledging it as "one of the better Test pitches we've play such as line markings and sponsor logo changes.

The collective efforts of the team to prepare the cricket pitch and outfield were recognised after the 2023 Boxing Day Test by global governing body for cricket, the International Cricket Council (ICC).

performance of the arena's playing surface. The MCG is the only Australian Test venue to receive top marks for our Test pitches in the ICC's pitch ratings for the last two years.

The MCG's pitch and outfield both received the highest possible ranking of 'Very Good' with evident consistency over the four-day Test.

Pakistan captain Shan Masood issued a glowing public assessment of the pitch in a post-match interview -

The importance of achieving an excellent standard in both the pitch and outfield is imperative to the future scheduling of cricket fixtures at the MCG, honouring our incredible history as the birthplace of Test cricket.

The ICC match referee oversees the process of monitoring the The arenas team has worked tirelessly to nurture the portable pitches and outfield in what has been a dedicated journey for the past five years with the results continuing to show.

Taylor Swift etches name in MCG folklore

It was a record-breaking three nights in February 2024 as global megastar Taylor Swift brought Taylor Swift | The Eras Tour to the MCG for three sold-out shows.

A total of 288,000 adoring fans attended the MCG from February 16-18, with thousands more gathered in Yarra Park surrounding the MCG to trade friendship bracelets, buy merchandise and sing along to their favourite songs from outside.

The 96,000 attendees at each show were Swift's highest individual crowds of her career, with Swifties from around the country filling the MCG with glitter, sequins and cowboy boots.

The shows also saw Swift enter the MCG record books as the highest selling artist and highest selling concert series of all time, surpassing Ed Sheeran's record set in March 2023.

With a setlist of 44 songs across a three-and-a-half-hour performance, the show was a journey through Swift's 18-year music catalogue through different eras from Fearless to Midnights.

MCC members were treated to a pre-concert hospitality experience, with 2,888 members able to enjoy a dining experience which included an à la carte menu and pre-show beverage package in the Members' Dining Room, Jim Stynes Grill, Long Room or Missymu by Shirley across the three shows.

MCC Member Survey Results

During December 4-20, 2023, all members were offered the chance to complete a 15-minute online survey conducted by our external research provider, Gemba, to assess overall member satisfaction. The survey included comparisons to the 2018 survey and used a 10-point satisfaction scale. A total of 7,515 members completed the survey, showing strong results. Notably, 57% of the total respondents were Full members.

We remain committed to continuous improvement and will engage and consult with members and visitors throughout the year as part of our ongoing Member Engagement Plan. This includes a mix of existing and new research activities including match day research, annual member survey, focus groups, ad-hoc pulse checks on burning issues and qualitative research.

In October 2023, Delaware North Merchandise (DNM) took over the merchandise operations at the Melbourne Cricket Ground, bringing extensive experience from across America and Europe including a new level of expertise and innovation.

From October 2023 to March 2024, DNM undertook a comprehensive upgrade of the MCG's merchandise offerings. They replaced four aging external outlets with five brand-new buildings designed with walk-in accessibility, allowing fans the opportunity to browse products before purchase. The internal Gate 3 MCG Shop and the Gate 2 MCC member merchandise store were also refurbished, providing a fresh, vibrant and inviting shopping experience.

Technology upgrades played a significant role in improving service speed and increasing match day transactions. Selfservice kiosks were installed, mobile order and pay options set up and a new customised website (mcgshop.com.au) featuring MCC/MCG-focused content was launched.

New outdoor match day stands have also been strategically positioned to better serve fans before and after events, providing an enhanced shopping experience by allowing fans to interact directly with the merchandise rather than purchasing from behind a counter.

The new merchandise operations have already achieved incredible results with the Taylor Swift merchandise operations in February 2024 setting new records for concert merchandise sales in Australia. These achievements include breaking Taylor's records for single-day pre-show sales and single show day sales throughout her career.

For the AFL season, the new store layouts enable increased variety in range and availability. No matter what event is being played at the MCG, DNM have successfully transitioned stock to ensure fans have access to their favourite teams' merchandise, whether it be AFL, soccer, NRL or other special events.

Creating a world-class merchandising experience at the MCG was a cornerstone of Delaware North's successful pitch to the MCC. Under the five-year MCC contract, DNM will continue to innovate the MCG Shop and match day stands to provide fans with a superior and more engaging shopping experience.

AUSTRALIAN SPORTS MUSEUM AND MCC TOURS KICKING GOALS



The Australian Sports Museum (ASM) proudly reached a new visitation milestone in early 2024, with more than 175,000 people exploring the museum and taking part in an MCG Tour over the last year.

The museum continues to attract past athletes to the space including former Wallabies Rugby Union Captain John Eales.

Ahead of the Wallabies' return to the MCG for the Bledisloe Cup opener in July 2023 – the side's first appearance at the 'G since 2007 - Eales visited the ASM where he discovered one of his past jerseys on display, labelling it a great honour to see this item at the MCG in what he referred to as "an iconic place for Australian sport".

In keeping with the venue's ongoing commitment to provide an inclusive environment for all patrons, MCG Tours have become more accessible for everyone with the addition of Auslan interpreted tours, while a new dedicated 'Keepers' Collection tour' has allowed visitors access to hidden sporting archives beneath the MCG.


For the first time in the venue's history, sporting fans have been able to discover hidden treasures never previously seen. This includes cricket equipment dating back to the 18th century, 1956 Melbourne Olympics memorabilia, iconic uniforms, vintage artwork and unique costumes from past concerts held at the stadium – each capturing a unique moment in sporting history.

150 Treasures of the MCC Library

Often regarded as the hidden gem of the MCG, the MCC Library deserves to be known as much more than a secret treasure nestled in the Members' Reserve. Many will be surprised to learn of its age and the fact that it celebrated its 150th birthday on September 6, 2023.

The milestone was formally recognised on November 1, 2023, with over 120 friends and Club dignitaries attending a celebratory luncheon in the Long Room.

A formal tribute to the MCC Library was delivered by prolific Australian cricket writer Gideon Haigh – a returning visitor and researcher who possesses a sincere attachment to the Library and is acutely aware of the essence collectively felt among those who have experienced what it has to offer.

The MCC Library was where Haigh researched his first cricket book - a space where fleeting sporting moments have been captured forever.

Beginning with a donation of 13 volumes of the Australasian newspaper in 1873, the MCC Library has grown to over one million items encompassing 119 different sports and to celebrate this significant milestone, the Club's librarians, David Studham and Trevor Ruddell selected 150 treasures of the extensive collection, listed on social media commencing in September 2023.

Robbie Williams' suit

A born entertainer with the ability to captivate a crowd of 100,024 before the first bounce of the 2022 AFL Grand Final – international pop icon Robbie Williams' pre-game entertainment remains part of MCG history, with a piece of this performance now on display within the Members' Reserve.

The Melbourne Cricket Club (MCC) Foundation – the philanthropic arm of the MCC – secured the pink suit after successfully bidding on the item as part of the McGrath Foundation's Pink Test Memorabilia Auction.

The bright pink Alexander McQueen suit, donated to the McGrath Foundation by Williams himself, is located on Level 3 of the Members' Reserve, with non-members able to see the display as part of the MCG Tour.



Women of the MCC

'On The Same Terms and Conditions: Women's Membership of the MCC' is a permanent display that has been created in the MCC Museum, documenting the long period leading up to Women Members, the conflict of the early 1980s, the key vote that changed the Club's rules, the experiences of the first female MCC Members and subsequent developments.

Chair of the MCC Foundation Sally Macindoe spoke at the official opening of the exhibition in February 2024, voicing the profound effect these changes to membership had for so many women and their family members who longed to feel part of the Club that plays a fundamental role in Australia's love of sport.

A MASSIVE YEAR OF CLUB FUNCTIONS

The MCC Club Functions team has continued to expand the vast range of function offerings available for members, including six new functions across the 2023/24 financial year.



Norm Smith Oration – June 2023

The Club's premier football function, the Norm Smith Oration, highlights the purpose and sense of community that comes from sport, in particular the great game of football.

Hosted by Tim Lane, the 2023 function featured a toast to football from outgoing AFL CEO Gillon McLachlan, who reflected on his earliest football memories and how he will still connect with football following his term as CEO. This was followed by a moving response from AFLW premiership player, Daisy Pearce, who shared a love letter to football, also pinpointing her first football memory and her journey through playing football when opportunities for women were limited.

- Committee Room by Grossi: Open to members for selected matches, the prestigious Committee Room by Grossi features a menu designed by renown Melbourne chef, Guy Grossi and also includes a Level 2 Reserved Seat in the Members' Reserve.

SPECIAL INTEREST CROUPS

The Club has six Special Interest Groups for members of all categories to enjoy. Special Interest Groups meet regularly for functions and events and provide an opportunity for members to connect and make the most of Club life.



Long Room Wine and Food Society

The Long Room Wine and Food Society is a prestigious Special Interest Group, holding monthly luncheons in the iconic MCC Long Room on the last Wednesday of each month since its inception in 1987.

With a membership of 280 and a waiting list of more than 860, the Society frequently books the Long Room to capacity for its luncheons – showcasing exquisite wines paired with delicious meals.

The highlight of the 2023/24 calendar was the August Luncheon, which welcomed over 250 members and guests to the Members' Dining Room – with pre-luncheon drinks in the Long Room. The Luncheon partnered with Ponting Wines – co-founded by cricket legend Ricky Ponting – paired with a specialised menu curated by Delaware North's Executive Chef Luke Rowden

Ponting himself made a guest appearance at the luncheon to provide insights into the formation of Ponting Wines and discuss topics from winemaking to cricket.

The function also saw an artist create an edible image of the MCG throughout the event, adding a unique and immersive touch to a memorable day.

Bridge Club

Throughout the year, the MCC Bridge Club has continued to provide members with the opportunity to engage in the game of Duplicate Bridge within the iconic surrounds of the MCG.

The Bridge Club meets every Thursday afternoon in the Hans Ebeling Room as well as fostering friendly competition through interclub matches. In 2023, the MCC Bridge Club participated in three interclub matches against the RACV, Royal South Yarra and Williamstown Bridge Clubs, followed by lunch in the prestigious MCC Committee Room.

As 2023 drew to a close, the Bridge Club celebrated another memorable year with a Christmas Lunch in the Yarra Park Room - a fitting conclusion to the year filled with both challenge and camaraderie.

Military Veterans' Group

The Military Veterans' Group is a Special Interest Group for past and present serving men and women of the MCC.

Women of the MCC

Strengthening partnerships AROUND THE GROUND

The Club announced a new contractor in early 2024, with Quayclean, one of the largest providers of cleaning, hygiene, and waste management services to major public venues across Australia, bringing vast stadium experience from a variety of major venues.

We thank long-serving partner and contractor, ISS Facility Services for many years of service and dedication.

An extension of the icon partner agreement with Coca-Cola Europacific Partners will see Coca-Cola remain the beverage partner to the MCG until 2031. Coca-Cola have been associated with the MCG for 60 years as the official supplier of carbonated beverages, water, sports and energy drinks.

The Club also acknowledges ongoing support from HG Sports Turf, an affiliation that dates back to 1998 when the first supply of stabilised hybrid turf was delivered to the MCG.

The team at HG Turf completed the MCG's second largest turf replacement following the Taylor Swift concerts held in February, making it the largest transformation in size since a full field of play replacement in 2014 which saw 18,000m² of turf replaced.

Over a 12-day period (from site set up to completion of the project), 12,000m² of turf was replaced – essentially two thirds of the playing surface - ahead of the first game played at the MCG for the 2024 AFL season.

With the last roll of turf laid on Friday March 1 – the arenas team were busy preparing the ground for four big Round 1 games commencing with Richmond versus Carlton on Thursday March 14.

The separation between existing and new turf was almost impossible to distinguish during Round 1.



BRINGING MELBOURNE'S BEST FLAVOURS TO THE MCG

In partnership with the MCC's hospitality provider Delaware North, the Club is continually seeking new ways to support and showcase the best Melbourne has to offer - from local legends to emerging new talent.

By capturing Melbourne's vibrant hospitality scene, the Club aims to enhance the culinary experience for its patrons, amplifying great Melbourne brands and produce to ensure that the food and beverage experience at the MCG reflects the city's diverse and vibrant food culture.

Several new offering were introduced this year, including:

- MCG Fresh providing healthy food options with fresh salads, sandwiches, and snacks made daily on-site.
- Big Chicken MCG offering crispy chicken burgers, wraps, and tenders with flavours that will change throughout the year.
- Cocina Mexicana bringing Mexican cuisine to the MCG for the first time with a menu that includes tacos, nachos, quesadillas and Mexican bowls.



Missymu by Shirley

In an exciting new addition to the members' dining experience, Missymu by Shirley was launched at the beginning of the 2023/34 cricket season on Level 3 of the Ponsford Stand.

"Missymu" is an affectionate name for daughter in Indonesia and the menu reflects Chef Shirley Summakwan's deep connections to family, culture and heritage. Inspired by the family kitchen where Shirley bonded with loved ones, she brings her passion for cooking to the MCC community.

Missymu by Shirley offers a shared dining experience that combines traditional Pan-Asian flavours with a contemporary twist, blending authentic street food with refined dining. The menu highlights the best of Asian cooking, featuring signature dishes like Mama Melly's Hainanese Chicken, After Church Prawn Toast, and the Spirit of Ah Gong's Dan Dan Noodles.



Royal Stacks at Barassi Café

The popularity of Royal Stacks at the MCG has led to its expansion of a third outlet as a full-service 55-seat restaurant dining experience in the Barassi Café. The renovated interior is a modern take on New York diners, featuring vibrant colours, rich timbers and a playful charm.

Patrons can order and dine in-store or order from a takeaway kiosk ordering system - a first at the MCG. This setup allows patrons to quickly return to their seats while enjoying Melbourne's favourite burgers and fries.



Premium Tour and Dine Experience

The ultimate Melbourne experience, blending the city's passion for sport and food, is now available as a Tour and Dine package. Guests can explore the inner sanctum of the 'G with a 60-minute tour, followed by a three-course set menu in the prestigious MCC Committee Room. With stunning views of the hallowed turf, Committee Room by Grossi offers a premium dining experience. With a menu curated by renowned chef Guy Grossi, patrons can sit back and enjoy a meal created with his signature Italian flavours made with the finest local produce.

developments include new TV broadcast suites and revamped bar areas featuring both state-of-the-art technology and thoughtful design.



TV Broadcast Suites

Due to high demand, two new custombuilt TV broadcast suites have been built on level 2 of the Olympic Stand. Construction began in early January and was completed in time for Round 1 of the AFL Premiership Season. Each suite measures 40 square metres with a platform elevated approximately 900mm above the lounge area and 1000mm above the concourse.



Betty Cuthbert Bar

As part of the development of the broadcast suites, the Betty Cuthbert Bar was relocated to the rear atrium space on level 2 at the Olympic Stand. The renovated area now offers a fresh, light-filled environment where up to 300 patrons can watch the game on a new 11.25 sqm indoor LED screen as well as enjoy views of Yarra Park. For added food outlet with a rotating menu.

On non-match days, this new space has become popular for functions and corporate events.




Ponsford Atrium Bar

Once an underutilised space, the Ponsford Atrium has been transformed into a new bar and food outlet for patrons to enjoy on match day.

Conveniently located near the Dean Jones Bar and Harrison Room, this bar has quickly become a popular spot that can fit up to 350 patrons.

New Tech Boosts MCG Experience

New cutting-edge technology has been implemented at the MCG to enhance the stadium experience for patrons - from the moment they enter until they are seated. These innovative offerings are designed to provide a seamless and efficient entry process and minimise time spent in queues.

Evolv

Evolv touchless security screening technology has been fully installed at all gates at the MCG, setting a new standard for stadium security in the southern hemisphere. This state-of-the-art system allows patrons to pass through the security without the need to remove personal items such as keys, phones or bags.

The technology's ability to detect prohibited items ensures every patron undergoes the same level of security screening efficiently, while preventing queues building up.



"The safety and wellbeing of all our patrons at the MCG are our top priorities. Introducing the Evolv system is a testament to our ongoing commitment to providing the safest environment possible for everyone attending events at this stadium, while also enhancing their overall experience." - Stuart Fox

Turnstile upgrade

All turnstiles have now been upgraded with NFC (Near Field Communication) technology - removing the need to scan barcodes or adjust phone brightness. Patrons can simply download their ticket from the Ticketek app to their wallet and tap and go at the turnstiles.

NFC also provides greater security with tickets encrypted and stored securely in the digital wallet on the device. There is no barcode displayed when the ticket is open and any screenshots of an NFC ticket are unusable as it does not access the underlying encrypted data, further protecting against the unauthorised access and resale of tickets.

This new technology also includes geo-fencing capabilities, alerting the patron's phone and bringing up their ticket when they are within 100 metres of the venue. However, if any patron prefers paper or barcoded tickets, all turnstiles support dual technology to accomodate.







MCG Express

The first two MCG Express outlets have opened in the Ponsford Stand at the city end of the stadium. The MCG Express food outlet is located on Level 2, just behind section 36, while the bar outlet is on Level 1, behind section 33.

MCG Express uses next-generation checkout-free technology powered by Zippin. Using AI, machine learning and sensor fusion technology, these new outlets allow patrons the opportunity to buy their favourite food and beverage items faster than ever before.

Further important upgrades

all centre changes

The Club has recently transitioned to the Cisco WebEx Contact Centre - a cloud-based solution featuring automatic call distribution, queue prioritisation and intelligent call routing. This upgrade aims to improve call handling, minimise wait times and enhance customer satisfaction.

Wi-F

The MCG's Wi-Fi infrastructure has been upgraded to improve coverage and security. Following a thorough tender process, Telstra Purple (in partnership with Cisco), was chosen to update the system, ensuring optimal performance and reliability for all MCC network needs.

Database security

Ernst & Young (EY) recently completed an audit on the Club's cybersecurity measures, including protection of membership data. The Club continues to invest in security measures and data protection practices.



Networking TO A NEW LEVEL

The MCG Network has continued to broaden its cohesive community, encouraging new connections and networking and business opportunities at an enticing variety of bespoke events.



MCG Network Ambassadors Abbey Holmes and David Zaharakis who both have strong connections to the MCG and its history, have been able to extract their own personal business learnings.

A number of major networking events were held in the past year, drawing on the build up to some of the largest sporting events held at the MCG and also relishing the unique backdrop of the $^\prime G$ – the ultimate place of connection, with a cherished sense of community.

The Spirit of ANZAC Luncheon, held in the week leading up to ANZAC Day, provided the opportunity for guests to honour those who have served and sacrificed for our country.



Special guests included the State President of RSL Victoria Dr Rob Webster, who led the ceremony along with MC Michael Roberts. Keynote speaker and Acting Chief of Veteran Services Benjamin Webb inspired the room with his story and service, whilst Collingwood Senior Coach Craig McRae and Essendon Senior Coach Brad Scott spoke to the significance of ANZAC Day within the AFL community.

The Spirit of ANZAC Luncheon continues to raise important funds for nominated event charity partner The ANZAC Appeal. Money raised allows the RSL to tailor specialist services that meet the needs of current and former service personnel, and the ongoing support required.

Hosted by Sarah Jones in June 2023, the Inner Sanctum Luncheon gave members and guests a behind-the-scenes look into the MCG and The Long Room, with a rare opportunity to hold the 2022 AFL Premiership Cup.

Special guests included MCG Network ambassadors David Zaharakis and Abbey Holmes, along with Melbourne Storm Coach Craig Bellamy and Collingwood Football Club Premiership Captain and CEO of Eclat Corporation Nick Maxwell, who shared exclusive stories and leadership insights.

In August 2023, guests in attendance for the Penfolds Luxury Dinner held in the MCC Committee Room enjoyed an intimate and exclusive evening over a three-course menu designed by Executive Chef Guy Grossi, paired with Penfolds wines from their Icons and Luxury portfolio.

Community Partnerships

As a sporting club at its heart and the custodians of one of the world's greatest sporting venues, the Melbourne Cricket Club believes in the significant impact and benefits that sport brings not just to individuals but to communities and society as a whole.

Through the philanthropic arm of the Melbourne Cricket Club, the MCC Foundation, we aim to preserve Australia's sporting history and enhance access to sport for all Australians.

The Club is proud to provide meaningful support to a number of causes and organisations which share in our beliefs and ambitions, and make a positive impact within our community.

National Indigenous Cricket Championships

Following the establishment of the MCC Foundation's partnership with Cricket Australia in 2022 and the return of the National Indigenous Cricket Championships (NICC) in February 2023, in October the Club was thrilled to bring the National Indigenous Men's and Women's cricket teams to Melbourne for a unique MCG Training Camp.

The selected players represented the best Aboriginal and Torres Strait Islander cricketers from across the country, with many chosen following standout performances at the NICC.

The camp not only offered an opportunity for participants to further their skills and train in a world-class facility, but also to immerse themselves in the history of sport at the MCG, as well as learn more about the significant connection that the Wurundjeri Woi Wurrung people have to the ground.

The training camp culminated in what would be considered a career highlight for many athletes – the opportunity to play on the hallowed MCG.

Facing the MCC Men's and Women's XI, the National Indigenous teams were well matched, with both games coming down to the last over. The National Indigenous Men's team held on to win by six runs, whilst the MCC Women's team seized victory by five runs.

Bachar Houli Foundation

As Presenting Partner of the Bachar Houli Foundation (BHF), the MCC Foundation proudly supports BHF in their efforts to deliver meaningful programs that foster social cohesion, employment pathways and education for more than 35,000 young Muslim men and women.

Having partnered with the BHF since 2019, the Club has hosted countless program participants at the MCG and 2023/24 was no different, with numerous MCG Tours, Australian Sports Museum visits, training sessions on the hallowed turf and development programs delivered for the Junior and Senior boys and girls programs.





As the official inclusion partner of the NICC, the MCC is proud to play a supporting role in the development of young Indigenous athletes. The NICC and MCG training camp forms an important part of the pathway for First Nations cricketers, fosters valuable connections between athletes and provides an unparalleled opportunity to share culture.

The Bachar Houli Foundation Iftar has become a fixture of the MCG's calendar, and in March more than 380 guests joined together in the Members' Dining Room to break the daily fast during the holy month of Ramadan. The event brings to life so much of what makes our partnership with the Bachar Houli Foundation particularly cherished, with the common thread of a love of sport far surpassing differences of background or belief.

The year also saw the launch of the BHF's Islamic College of Sport, an innovative education initiative which, providing an alternative to traditional VCE studies, brings a sporting lens to curriculum and aims ultimately to support more Muslim men and women to engage in careers in sport.

Melbourne Indigenous Transition School

The Melbourne Indigenous Transition School (MITS) exists to empower Indigenous students from regional and remote communities to achieve their educational aspirations in Melbourne.

Located near to the MCG in Richmond on Wurundjeri Country, MITS provides a high-quality, culturally safe learning environment for Year 7 and 8 students, before supporting their transition into places at partner schools across Melbourne.

The MITS student community consists of up to 100 young First Nations people from Years 7 to 12 pursuing education in Melbourne while living together in bespoke boarding houses.

Since December 2021 the MCC's support of MITS has enabled more than 70 of their students to participate in organised

club football in the local Richmond community. Playing for Richmond Junior Football Club in the Yarra Junior Football League, two teams with MITS students made it through to the 2023 Grand Final, while two MITS students finished first in their division in the league's best and fairest.

The sporting appetite of the MITS students has continued to grow and in late 2023 the MCC was pleased to commit further funds to allow students to participate in the local basketball league.

Beyond sporting pursuits, the Club continued to welcome MITS students to the MCG across the year, with activities ranging from visits to the Australian Sports Museum and special kick-to-kick opportunities on the hallowed turf, to a relocation of the Year 8 classroom to the stadium for a two-week period in October/November.



Western Bulldogs Community Foundation - CALDplay

The MCC Foundation's partnership with the Western Bulldogs Community Foundation (WBCF) and their CALDplay program strongly reflects the Club's belief in the power of sport to serve as a bridge between communities and transcend differences of background or language.

CALDplay is a free program providing culturally and linguistically diverse (CALD) adults and children newly arrived to Australia with the opportunity to engage in sport as a means to improving their English, developing skills and increasing social participation.

As presenting partner of CALDplay the MCC Foundation has been proud to welcome approximately 1000 program participants to the iconic MCG in the 2023/24 period.

One highlight of the year was in September 2023 when, following a six-week program focused on the history, rules and key skills of cricket, 350 CALDplay participants arrived at Australia's spiritual home of the game. From exploring the MCG's indoor cricket nets and cricket viewing rooms, to seeing artefacts and learning stories of the game in the

Australian Sports Museum, the day culminated in some friendly cricket games and activities out in Yarra Park.

For many it was their first visit to the stadium and as the managers of the People's Ground it was our privilege to welcome them.

The Sports Excellence Scholarship Fund (SESF) aims to break down the financial barriers preventing young Australian athletes from pursuing their goals and representing their state or country in their chosen sport.

Since commencing a partnership in 2021 the MCC Foundation has helped SESF provide hundreds of scholarships for students from low socio-economic, Indigenous or rural and regional backgrounds, supporting them to achieve their dreams and build skills for life through the power of sport.

In 2023/24, 60 SESF x MCC scholarships were awarded to skilled and deserving athletes involved in diverse sports from AFL and cricket to lawn bowls and karate.

The scholarship recipients came from all states in Australia and included Indigenous athletes, athletes with a disability and several athletes from regional and remote areas.

The Club was pleased to host a number of SESF athletes at the MCG throughout the year, including a special visit which saw a young Rugby Union player and SESF x MCC scholarship recipient met former Wallabies captain John Eales ahead of the Bledisloe Cup in August.

Ltyentye Apurte (Santa Teresa) Oval Project

2023/24 saw the MCC Foundation continue to support the Ltyentye Apurte (Santa Teresa) community with the management and maintenance of the 'MCG of the Desert'.

Since 2019 the Club has been involved in a joint venture with the Atyenhenge Atherre Aboriginal Corporation (AAAC) and the Melbourne Football Club to grass the red clay oval of Santa Teresa, a remote Indigenous community 80km southeast of Alice Springs.

Special Olympics Australia

Undoubtedly the highlight of 2023/24 for Special Olympics Australia was the World Games which took place in Berlin in June 2024.

Prior to the Games, the MCC was pleased to welcome a group of competing Special Olympics athletes from Victoria to the 'G for a formal send-off event and uniform presentation. The group, supported by the Law Enforcement Torch Run, were celebrated in the Australian Sports Museum – a fitting venue given the many Australian sporting stories it holds.

More than 7000 athletes with intellectual disabilities from over 190 nations competed at the Games in June. Australia was represented by 64 athletes in the green and gold across nine different events and were rewarded for their efforts with a total of 45 medals.

Special Olympics Australia was the MCC Foundation's inaugural community partner, and since 2019 the Club has proudly supported their work to foster a culture of inclusion and ensure sport is accessible.

In addition to the scholarship program SESF provides numerous mentoring and development opportunities to help students excel in their chosen sport and beyond. The MCC proudly welcomed past SESF scholarship recipients and program ambassadors including Olympic Racewalker Bec Henderson and Para triathlete Jack Howell to film a video masterclass focused on high performance and how athletes can best prepare for challenges and events.



Representatives from the MCC were pleased to visit the community in February 2024 and despite the ongoing challenge of growing grass in the harsh Central Australian climate, the oval remains in a strong condition.

The oval has become a gathering place for people of all ages and abilities not only within the Ltyentye Apurte community but beyond, hosting everything from Central Australian Football League games and the local women's team training to Auskick clinics to community sports days.



National Aboriginal and Torres Strait Island Sport Awards

On November 11 2023 more than 350 attendees came together at the MCG to recognise and honour the outstanding achievements of Indigenous athletes, coaches, and sporting organisations at the National Aboriginal and Torres Strait Island Sport Awards (NATSISA).

The event celebrated sporting representatives from all levels of sport in Australia – from grassroots to the elite – and was the first time the awards had been presented in 20 years.

The MCC Foundation was pleased to support the resurrection of the NATSISA by sponsoring one of the key awards on the night, the National Lifetime Achievement Award, which was presented to Cathy Freeman OAM.

The awards served not only as a way to honour the past but to inspire the future generations of sporting athletes.

Community Support and the MCG

In addition to the MCC Foundation's community partnerships, the Club also supports a number of other charitable initiatives by using the size and scale of the mighty MCG to help shine a light on worthwhile causes.

Fight MND - Big Freeze

Co-founded by Neale Daniher in 2014 following his own diagnosis with Motor Neurone Disease, Fight MND aims to find effective treatments and ultimately a cure for the insidious beast that is Motor Neurone Disease.

Since 2015 the MCG has been proud to host Big Freeze, which sees prominent Australian personalities taking the plunge down the Big Freeze slide and descending into the icy pool below.

In 2023, nine surfers braved the slide, reflecting the ninth year of the event. Surfer Mick Fanning, jockey Michelle Payne and actor Eric Bana were amongst those personalities who were cheered on by the blue beanie bedecked crowd ahead of the King's Birthday clash between Melbourne and Collingwood.

The events of Big Freeze 9 in 2023 raised an incredible \$15,821,644 for Fight MND.



Donations

The Club also receives and fulfils a large number of requests for smaller donations from many charities and community organisations each year. In 2023/24 over 150 fundraising events, spanning school trivia nights to gala dinners were supported with either a voucher to the Australian Sports Museum or a unique MCG experience.



Breast Cancer Network Australia – Field of Women

For the first time in five years, the Breast Cancer Network Australia's (BCNA) Field of Women returned to the MCG, prior to the Round 23 AFL Pink Lady match between Melbourne and Hawthorn on Sunday August 20.

The sun was shining and emotion ran high as more than 10,000 people walked onto the hallowed MCG turf to form the shape of BCNA's Pink Lady, paying tribute to all those who have been diagnosed and all those who, through more indirect ways, have been touched by breast cancer.

The 2023 event was staged as part of BCNA's 25th anniversary year, and the sea of pink ponchos also included a smattering of blue in order to represent the men who have experienced breast cancer.

The MCC is proud to be able to support BCNA in bringing the statistics and impact of breast cancer to life in such a visually powerful way, and to help unite the community for an incredible cause – to raise funds and awareness for breast cancer research, support and care.

Melbourne City Mission - Sleep at the 'G

In May 2023, the stadium was thrilled to once again play host to Melbourne City Mission's flagship fundraising event, Sleep at the 'G.

For more than a decade, Sleep at the 'G has invited Melburnians to spend the night on the cold concrete floor of the MCG in order to raise much needed funds and awareness for the 7,600 vulnerable young people aged 12-24 in Victoria who, on any given night, don't have a safe place to call home.

The 2023 sleep-out was the first time the event was held 'live' at the venue since 2019, with the last three years held virtually or postponed due to the COVID-19 pandemic.

On May 16 more than 800 people rolled out their sleeping bags and braved a chilly Melbourne night at the 'G. The collective efforts of everyone involved raised an incredible \$780,000, which has contributed to the construction of accommodation for Victoria's homeless youth.

The Club is particularly proud of the team of 24 Melbourne Cricket Club staff who slept out and raised more than \$23,000 for this important cause.

Reconciliation Action Plan

The land where the MCC and MCG are situated is a sacred place. The Wurundjeri Woi-wurrung people invited the Kulin Nation to this land; it was a place for corroboree, ceremonies, connection and celebrations. As the current custodians of ground, the Club is privileged to continue this tradition.

As an organisation with great reach and recognition, we believe we have a responsibility to lead change. In 2021 the Club made a formal commitment to the reconciliation journey and since then we have sought to promote and celebrate Aboriginal and Torres Strait Islander peoples and their cultures through our sphere of influence.

Following the completion of the MCC's inaugural Reflect RAP in 2022, in 2023/24 the Club commenced the next tier in the RAP framework – Innovate. Implemented over two years the Innovate RAP centres on taking action and making change to ultimately achieve our Club's vision for reconciliation.

The year saw the Club significantly strengthen its engagement with the Wurundjeri Woi-wurrung Cultural Heritage Aboriginal Corporation (WWCHAC), which represents the Traditional Owners of the land on which the MCG is based.

A particularly meaningful collaboration between the MCC and WWCHAC occurred in September, with a small delegation of MCC staff joining a group of WWCHAC representatives to plant five unique river red gum seedlings at Coranderrk.


Established in 1863 in what is now known as Healesville, Coranderrk served as a reserve for Aboriginal people of southcentral Victoria until 1924 and is strongly connected to First Nations Peoples' fight for self-determination and land rights.

The river red gum seedlings were propagated from one of the three Scarred Trees found in Yarra Park. Scarred trees, which retain the marks from when bark was removed to create items such as canoes, shields or shelters, provide an important living connection for Aboriginal people to their ancestors and cultural practices.

The MCC's journey to propagate seedlings from one of Yarra Park's living scarred trees began more than four years ago and stemmed from the Club's deep appreciation of the tangible and intangible significance of the trees to the Wurundjeri people.

Bringing the project full circle, in early 2024 the WWCHAC and MCC representatives planted a further three scarred tree seedlings in Yarra Park to grow alongside the original trees.







- In April 2023 MCC staff joined with representatives from Visit Victoria, the Melbourne Football Club and MCC Foundation community partner the Melbourne Indigenous Transition School (MITS) to take part in an afternoon of Traditional Aboriginal and Torres Strait Islander games.
- The Club celebrated National Reconciliation Week with a range of events
 which supported Aboriginal and Torres Strait Islander businesses, including
 a Wayapa mindfulness session on the MCG, a Q&A session with Nyul Nyul
 Saltwater artist Lowell Hunter and a cooking workshop with acclaimed Torres
 Strait Islander chef Nornie Bero.
- The launch of the Indigenous Trail in the Australian Sports Museum.
 Designed particularly for school groups and kids, the trail invites visitors to explore the museum through a collection of Indigenous sporting moments which are celebrated in the stories and objects in the museum. A dedicated learning resource is available post visit to encourage further discussion in the classroom.
- In the lead-up to Sir Doug Nicholls Round, Wurundjeri Elders from the WWCHAC were invited onto the 'G to paint the Aboriginal flag in the goal square. The Club was also thrilled to welcome students from our community partner the Melbourne Indigenous Transition School to perform on the Yidaki (didgeridoo) in the Committee Room ahead of the game.
- Wurundjeri Elders were engaged to perform Welcome to Country ceremonies
 ahead of a number of significant Club functions and events in the year. This
 forms a part of the Club's commitment to reconciliation and sharing the
 cultural significance of the land on which the MCG is based with all visitors.
 A particularly memorable event was the Gala Day for MCC Foundation
 Community partner CALDplay. For most of the attendees this was their first
 experience of a Welcome to Country delivered by an Indigenous Elder and
 was a special moment for all involved.
- The Club implemented a number of bespoke training programs for permanent MCC staff, event staff and MCC/ASM volunteers. Each program was tailored to the specific audience and aimed to address gaps in knowledge of First Nations issues and history, educate on the significance of the land on which the MCG is based, as well as help individuals feel more confident navigating Aboriginal and Torres Strait Islander culture, customs and practices.



The Club's commitment to reducing its carbon footprint is fundamental in maintaining the MCG's status as a world-class stadium. This financial year, we were proud to announce a landmark achievement in our sustainability journey.

Carbon Neutral Operations Certification

The MCC has become Australia's first sporting club to achieve Climate Active certification for its operations. This achievement recognises the Club's commitment to reducing its carbon footprint by minimising emissions and investing in carbon offset projects, ensuring the MCG remains a world-class stadium.

Achieving this certification reflects over a decade of dedicated efforts in enhancing the Club's sustainability across various operational areas including energy use, waste management and water conservation. We have reduced emissions where possible and compensating the remainder by investing in carbon offset projects to and ensure our operations remain carbon neutral.

Scope of certification

The certification evaluates the MCC's operations at the MCG, the Australian Sports Museum and Yarra Park. It covers efforts to reduce carbon footprints, conserve resources and enhance environmental sustainability through energy and water conservation, waste management and carbon offsetting. However, it does not include the physical infrastructure or the activities of partners and tenants using the grounds for an even


2023 Environmental Achievements

- Refrigerant replacement project where suitable refrigerants were replaced with lower global warming potential (GWP) refrigerants. This initiative reduced emissions by approximately 598 tCO₂e.
- Identify contractor emissions in line with services provided to the MCC. This initiative reduced emissions by approximately 264 tCO₂e.
- Implementation of waste diversion dashboard reporting.
 This initiative reduced waste to landfill, resulting in an emissions reduction of approximately 109 tCO₂e.

Future Steps


The Club aims to achieve net zero emissions across all scopes by 2040, targeting a 42% reduction in emissions from a 2021 baseline by 2030. Reducing Scope 1 and 2 emissions will involve further renewable energy use, electrifying cooking appliances and lowering refrigerant emissions. The Club also plans to minimise Scope 3 emissions by improving waste diversion, reducing water consumption and managing food waste. Continuous engagement with suppliers to reduce supply chain emissions is also another key priority.







The Melbourne Cricket Club mourns the loss of the following individuals whose contributions to the Club, the MCG and the broader sporting community will be forever cherished and celebrated.



Ronald (Ron) Barassi AM

In September 2023, Australian football legend and 50-year MCC member Ron Barassi passed away. A towering figure in AFL, Ron's contributions and influence on the game were immense and enduring.

Ron's connection with the MCC and MCG spanned over seven decades, during which he became synonymous with the ground's rich history. A player and coach of extraordinary vision, he was instrumental in shaping the AFL, leaving an indelible mark with his innovative strategies and relentless drive for excellence.

From 1953 to 1964, Ron played 204 games for Melbourne, kicking 295 goals. He was a member of six Melbourne premiership teams (1955, 1956, 1957, 1959, 1960, and 1964) and captained the Demons from 1960 to 1964. He won two Truscott trophies as Melbourne's best and fairest (1961 and 1964) and was the club's leading goalkicker in 1958 and 1959.

In 1965, Ron left to become captain-coach of Carlton. He played 50 games (35 goals) for the Blues from 1965 to 1969 and coached them to premierships in 1968 and 1970. He retired as Carlton coach after the 1971 season but soon led North Melbourne to their first VFL premiership in 1975, followed by a second in 1977.

After leaving North in 1980, Ron returned to Melbourne as coach in 1981, marking the beginning of a new era for the club and stayed until 1985. In 1993 Ron took on the challenge of coaching Sydney and helped turn the club's fortunes around before retiring at the end of the 1995 season.

A member of the AFL Team of the Century and the Sport Australia Hall of Fame, Ron was awarded "Legend" status when the AFL Hall of Fame was inaugurated in 1996. A statue of Ron was also unveiled outside Gate 4 of the MCG in September 2003.

As a 50-year member of the MCC, Ron's influence extended beyond the field. He was a cherished member of the Club, known for his dedication to the game and promoting the values of sportsmanship and integrity.

In recognition of his extraordinary legacy, a state funeral was held at the MCG, allowing the community to honour a true sporting icon. Ron Barassi's legacy will continue to inspire future generations, ensuring his place in Australian sporting history remains forever.



Graeme "Hedley" Howarth


Former MCC player Graeme 'Hedley' Howarth passed away at the age of 87 in March 2024. Graeme's playing career at Melbourne spanned 296 games across all grades from season 1954/55 to 1978/79, leaving an indelible mark on the Club. He captained the MCC Third XI from 1967/68 to 1974/75 and the Fourth XI from 1975/76 to 1977/78, playing an influential role in mentoring many emerging players.

Former teammate and MCC Vice-President David Crow highlighted Howarth's influence at the Demons, noting his ability to nurture younger players and his dedication to the Club.

"He demonstrated to us a fierce desire to win and a toughness that many of us needed, but he was always there as a mentor and a friend. He truly loved the MCC; it was a huge part of his life and he has always followed the results carefully each week," he said.

Graeme debuted in 1958/59, playing 24 matches in the First XI, taking 24 wickets at 24.37. He also played in multiple Premiership teams, contributed to multiple Club Championship wins and contributed significantly as a member of the MCC Cricket Sub-Committee for over 25 years.

Awarded the Ebeling Award in 1994, Graeme Howarth's affable yet passionate approach made a stellar contribution to the Melbourne Cricket Club and the broader game.





MEMBER BEHAVIOUR AND CODE OF CONDUCT

As we reflect on another busy year at the Club, it is essential to address the importance of membership integrity and strict adherence to our Club's Code of Conduct for the enjoyment and benefit for all members.

Disciplinary cases in the past year have highlighted a significant increase in breaches of our rules and regulations. Many of these cases involve card misuse with members either failing to take due care of their membership cards or knowingly allowing the use of their cards by others, despite the clear rule that cards are strictly non-transferable.

Inappropriate use of ticketing privileges has also been prevalent, including the purchase of child tickets for adult use and neglecting proper care of barcodes. Such actions not only violate Club Rules but also undermine the integrity of our membership system.

We are committed to having our Club's environment as a safe, inclusive and welcoming one for all members and their guests by ensuring there is respectful behaviour, free of abuse both verbal and physical, and adhering to the rules and regulations of the Reserve.

In this financial year, penalties handed down have included:


- Racial vilification: expulsion
- Abusive language and threatening behaviour: 12 months to four years' suspension
- Fraudulent conduct: four years' suspension
- Misuse of ticketing privileges/guest misconduct: two to three years' suspension
- General anti-social behaviour: Reprimand to two years' suspension
- Disrespect to staff/failing to adhere to inductions: two years' suspension
- Membership card misuse (whether knowingly lending card or not taking due care of card): 12 months to three years' suspension

Members are reminded of the Club's Code of Conduct and Rules throughout each year via member communications, including President's messages, to ensure that any guests introduced to the Members' Reserve are aware of their responsibilities. It is expected a member attends a match along with their guests, as they are ultimately responsible for their experience and conduct in the Members' Reserve. This includes adhering to dress regulations and respecting staff when informed of any non-compliance. A copy of the Club's Code of Conduct and Discipline & Appeal Sub-Committee's penalty guide can be found on the Club's website.

Please remember, your membership card is strictly not transferable under any circumstances, and it is your responsibility to ensure its security to prevent misuse.

The Club is committed to keeping the expectations and responsibilities of members at the forefront of communications throughout the year in an effort to always maintain a respectful and enjoyable environment for all. Poor behaviour is encouraged to be reported immediately to event staff members or via the anti-social text messaging platform, which has signage displayed throughout the Members' Reserve and MCG. Detailed and confidential incident reports are invaluable in addressing these issues effectively and securing convictions when necessary. Member vigilance and cooperation are essential in maintaining the integrity and enjoyment at the MCG.

Issues outside of an event day at the MCG can be shared with the Club through numerous channels.

Oliver Allen travelled to Taiwan to represent Australia at the U12 World Baseball World Cup while Will Kent and Max Saggers have helped their U18 Victorian team to glory at the 2024 Australian Youth Championships.



Bowls celebrated the success of Courtney Thompson after being crowned the 2024 Bowls Victoria Novice Singles Champion at the Mulgrave Country Club. The Section also hosted its inaugural MCC Triples Classic at its home at Swinburne Avenue in Hawthorn where it welcomed players around the state and country with Bowls Australia ranking points up for grabs.

It was a momentous summer for **Cricket** with both Premier Men's and Women's teams having the opportunity to play for premiership points on the MCG - a first for the Women's cohort. All teams representing the MCC at Victorian Premier Cricket level continue to consolidate the Club's fundamental role in supporting and developing players as they strive to progress to interstate and international representation.

The depth of emerging talent across all teams attracted noticeable attention internally and externally, with 11 cricketers representing the Club at domestic and/or international level - a new wave of talent attracting rightful recognition. Fergus O'Neill was among the most prominent of these, winning the Bradman Young Cricketer of the Year Award as the best emerging male player in the country as well as several Victorian awards: the Bill Lawry Medal (as their best Sheffield Shield player), Dean Jones Medal (best in Marsh One Day Cup) and the John Scholes Trophy (as voted by the players).

Our Premier Women's cricketers completed a phenomenal season, winning the First XI, Second XI, Third XI and Under 18 Premierships and securing the Club Championship for



the fourth time in five years. It was a truly remarkable performance by captain/coach Teagan Parker and her charges.

Ella Hayward captained the Victorian Women's Indigenous team at the National Indigenous Cricket Championships, run in conjunction with the MCC Foundation, where she was also named in the Team of the Tournament.

The MCC also fielded Women's and Men's teams for matches on the MCG against their respective National Indigenous XIs, as part of a broader training camp which formed part of the MCC Foundation partnership.

The 22nd Men's First XI Premiership flag (won in season 2022/23) was officially unfurled at the Albert Ground in October 2023. The Women's First XI flag of 2023/24 will follow suit later this year.



Croquet is in the process of upgrading its facilities at Glen Street, Hawthorn, with renovations to include a larger court, new grass irrigation and drainage, and new courtside seating an addition that will elevate the overall playing and spectator experience. Lachlan Berryman's impressive performances in 2023 saw him selected to represent Australia at the 2023 World Croquet Championships in the United Kingdom. Lachlan also awarded the Section's Chairman's Award for his contributions outside of his playing commitments, helping coach and mentor other members.

As one of the newer sections, Football continues to build both on and off field, drawing inspiration from the Melbourne Football Club's AFLW side. Throughout the year both clubs enhanced their relationship with one another as part of an ongoing development across all teams to ensure sustained success. Players and staff enjoyed joint training sessions held at Beaumaris Secondary College and Melbourne Football Club AFL and AFLW matchday experiences.

The Melbourne Football Club was awarded the McClelland Trophy in 2023 - receiving the award for the first time in its revamped format - as recognition for the best combined on-field performances by both its AFL and AFLW programs throughout the home and away seasons.

Golf celebrated its 25th anniversary in November, having developed from one of the Club's special interest groups into a sporting section. Groups enjoyed tours to the United Kingdom, playing at Sandy Lodge against Marylebone, and to Thailand, where a social match was played against Royal Bangkok Sports Club. The Section continues to grow and offer its members the opportunity to regularly play at Melbourne's premier courses.



For **Hockey**, an inaugural Men's Premier League Premiership was the defining moment of the season, with the side achieving the ultimate success having fallen agonisingly short in previous years. Goals to Simon McKeever, Jayme Walsh and Tony Wilson ensured the Dees defeated Waverley Hockey Club 3-1 and went one better than their 2022 Grand Final appearance. Luke Jackson was awarded Premier League Player of the Match for his outstanding performance.

Lacrosse enjoyed a strong year, with a return to Lacrosse Victoria's highest men's division and national and state selection. The men's State Grade side secured a finals berth on its return to the competition with Steve Stojkos winning the league's best and fairest and Tyler Reynolds taking out the league's top scorer. The side also featured a host of young guns who have graduated through the section's successful junior program. Josh Nicholl and Joseph Shobbrook were both selected to represent Australia at the World Junior Box Lacrosse Championships in Canada.

Three of **Netball**'s five teams finished the home-and-away season undefeated in the Premier division, Alex Ball, Jen Barrett and Geri Ryan were celebrated as they became the first three players in the Section's history to play 300 games for the Club.

Real Tennis toured the United Kingdom and played off against traditional rivals Marylebone Cricket Club at Lord's, with the hosts claiming the Cowper-Cowdrey Cup. The Section also awarded former Australian Test cricketer Bob Cowper OAM Life Membership at its inaugural annual dinner for his contribution to the Club and the sport.

Squash finished a stellar year with an incredible five Club Circuit Spring premierships including its top-grade A1 bringing home the pennant and reclaiming their place as the state's top team. Joanne Joseph, Courtney Scholtz and Haider Naqvi were selected to represent Australia at the 2024 World Junior Squash Champions in Houston, Texas. The trio were also a part of the successful Victorian team that defeated Queensland, which had won the event for 14 consecutive years, at the 2023 Australian Junior Squash Championships.

Section Chair, Peter Wright OAM, was honored by Squash & Racquetball Victoria with their major award 'The Paul Vear Award' for his commitment to squash. At player Rex Hedrick was also inducted into the Squash & Racquetball Victoria Hall



2023/24 was the year of international representation for Target Shooting with many members competing for their country overseas. Andrew (Angus) Cameron became the first Australian to win the English Open trophy, James Willett, Laetisha Scanlan and Brittany Melbourne were all selected to represent the ISSF Australian Trap Team, with James also being selected to represent Australia at the 2024 Olympic Games in Paris.



Tennis claimed consecutive Tennis Victoria Women's Premier League triumphs as the team defeated Hume in the grand final. The campaign was led by WTA Tour professional Jaimee Fourlis who won the Premier League Aces Award for her consistent high performance throughout the tournament. The team also featured young gun 14-year-old Scarlett Dattoli showcasing the Section's rich junior program. The men's side narrowly missed out on also going back-to-back finishing runners-up to Grace Park Hawthorn.

The Club is pleased to have welcomed two new chairs to the Sporting Sections, with Jordana Dymond elected Chair of MCC Glen Iris Valley Tennis Club replacing Peter Gillieron who stepped down from the role.

Yvette Costello has been elected Chair of the MCC Football Section taking over from interim Chair Justin Griffin.

RETURN OF RECIPROCAL **VISITS**

In the Club's 185th year, the 14 Sporting Sections representing the red, white and blue continued to honour the rich history of the Club, while forging new pathways for the next generation of athletes, coaches and volunteers. While it was cricket that afforded the Club international recognition, the MCC's relationship with a range of overseas reciprocal clubs has strengthened over time.

Thirty years from the inaugural outing between two of the world's largest and most prominent sporting clubs, the MCC ventured to the UK to face the Marylebone Cricket Club for the 17th time, returning to Lord's Cricket Ground in July.

Melbourne Cricket Club First XI opening batter Charles Lill captained the visitors following an injury to appointed skipper Will Pucovski. Lill's elevation is a fitting story with a family legacy dating back to his grandfather, Dr John Lill, who captained the MCC in the inaugural match three decades ago.

The hosts claimed victory by 29 runs - a loss on the scoreboard but a renewed bond away from the pitch, with the MCC side indebted to its hosts for the incredible hospitality and access at Lord's, also experiencing the historic Members' Pavilion and Long Room post play.

The Club embarked on a second overseas trip one month later, with a group of representatives from the Bowls, Cricket and Golf sections, along with MCC President Fred Oldfield and CEO Stuart Fox, warmly welcomed by counterparts at the Royal Bangkok Sports Club (RBSC) in Thailand.

The relationship between the respective clubs began in 2017, with the highly anticipated social sporting tour eventually taking place in August 2023.

A busy itinerary involved social games between the teams, with the visitors also getting to experience the diverse offerings of the main club at RBSC including indoor sporting facilities and dining spaces.

The MCC cricketers ventured to the Asian Institute of Technology to face the Thai National Youth Team, with MCC 1st XI Captain Blake Thompson producing a number of highlights for the visitors hitting 152 off 96 balls.

Experiencing a full sized 18 hole golf course in the heart of Bangkok was a unique opportunity for all of those involved from the Golf Section, while the Bowls Section relished the opportunity to face their opponents at the RBSC Polo Club.

A deeper understanding about the common practices, experiences and values shared between the two clubs has strengthened the relationship. A trip years in the making has proven to be an invaluable experience for all involved.



HANS EBELING AWARD 2023 Michael Sholly

More than 30 years of exceptional service to the MCC Cricket Section as a player, coach and administrator saw Michael Sholly awarded the prestigious Hans Ebeling Award in November 2023, formally recognised in front of a range of Club and sporting representatives.

An unexpected call to confirm his place in the First XI side was the innocuous beginning of what would turn into a 32-year playing and coaching career at the Club for Michael Sholly. He was involved in 267 First XI matches as a player and a decade of coaching, which included mentoring several players who would go on to represent Australia, and leading multiple premierships across a range of grades.

Michael remained closely tied to the Club following the end of his playing and coaching career, joining the MCC Cricket Sub-Committee in 2007 and he was also appointed the inaugural Chair of the Premier Cricket Committee, with a strong determination to establish the Club's inaugural women's cricket teams and facilitate continual growth.

Governance

Melbourne Cricket Club is a body corporate incorporated under the Melbourne Cricket Club Act 1974, consisting of persons who are members of the Club.

The business and affairs of the Club are overseen and controlled by the MCC Committee. The Committee comprises members of the Club elected to honorary office-bearer positions - President, three Vice-Presidents and Treasurer - and up to nine other elected members. The Committee meets at least 10 times a year for the purpose of overseeing all aspects of the Club's business plan and objectives. It also deliberates on its responsibilities as ground manager of the Melbourne Cricket Ground and Yarra Park for the MCG Trust. Additionally, the Committee reviews the performance of the Club's management team in consultation with the Club's Chief Executive Officer, measuring results against the business plan objectives, ensuring compliance with legal requirements and monitoring the strategic Risk Management Plan.

Governance

The Club is committed to overall strong governance across its operations and management of the MCG. Such governance delivers on the MCC's current five-year Strategic Plan.

Cyber security – management and monitoring

The IT & Innovation department has engaged a third party security operations centre to provide 24/7 monitoring of all cyber security threats. This enhances our capability to provide even greater levels of protection to MCC membership data from any external cyber-attacks.

Modern slavery

The MCC, as ground manager of the MCG, is committed to an ongoing program aimed at identifying, assessing and mitigating the risks of our operations and supply chains contributing to modern slavery.

The MCC takes its obligations under the Commonwealth Modern Slavery Act 2018 seriously and continues to commit to an ongoing program of business and procurement practices to ensure our risk of contribution to modern slavery is understood and mitigated.

Safety

The Club is committed to prioritising a mentally healthy and a physically safe workplace for all staff, contractors and MCG tenants. This commitment also extends to our visitors and patrons who attend our venue.

This is supported by the successful implementation and ongoing improvement of our Health and Safety Management system which is certified to ISO45001:2018 and is reviewed regularly through reporting to the Committee and its Sub-Committees.

The Club also promotes work practices and behaviours that support positive mental health, by identifying, managing and where reasonably practicable eliminating or minimising psychosocial hazards and risks in the workplace.

Security

Given the MCG's status as an iconic event venue in Australia. the Club has placed high importance upon the management and mitigation of security risk issues. Accordingly, several strategic security management initiatives are ongoing. These measures have enhanced the safety of ground users on event and non-event days. The Committee and Club management will continue to develop, implement and assess security risk reduction strategies.

Legal

The MCC engages Ashurst, a leading multinational law firm and advisor to corporates, financial institutions and governments worldwide, to provide the Club with guidance on its constitution as well as being involved in all contract negotiations. Processes and policies are in place to ensure a consistent approach to contracts, privacy, intellectual property protection and legal compliance.

Diversity & Inclusion

The MCC, as Ground Manager of the MCG - the People's Ground, has a responsibility to represent the diversity of all Australians. The Club has an endorsed Diversity & Inclusion Strategy which is currently implementing a number of strategic initiatives to further develop an inclusive culture for all involved with our great Club and the broader MCG community.

Gender Equality

In accordance with the requirements of the Workplace Gender Equality Act 2012, the MCC lodges an annual public report with the Workplace Gender Equality Agency. The Committee and Management of the MCC are deeply committed to ensuring a gender balance through all staffing areas of the Club and are proud there has been considerable improvement in this space over recent years.

MCC Committee succession

The skill and experience set required by the MCC Committee as a whole is that necessary to govern the running of a large public asset with a significant business as well as a club of more than 150,000 members. The Committee's role is to represent members of the Club to the executive under the leadership of the Chief Executive Officer.

Some matters are reserved for decision by the Committee, including Club rule changes, large financial transactions and capital works, strategy and the business plan. The executive reports regularly on

the discharge of its responsibilities to the Committee or the sub-committees that have been established under its governance framework.

In order to govern effectively, the Committee believes it needs members with skills and experiences in a wide range of areas. These may include finance and accounting, audit, risk, health, safety and the environment, contract negotiation and management, strategy, marketing, legal, human resources, construction, large capital projects, sport and sporting bodies both professional and amateur, communications and government.

A Succession Sub-committee has been established to assess the skill and experience represented on the Committee and to ensure that when a casual vacancy occurs candidates are selected who not only meet any skill or experience need identified such that the Committee can collectively meet their responsibilities, but also demonstrate behaviours in line with the MCC's values and culture.

Committee members are submitted to members for election in accordance with term limits. Any Full member of the Club may also submit him or herself for election.

Nature of Operations and Principal Activities

The principal activities of the Club during the year were the ground management of the Melbourne Cricket Ground ("MCG") and the encouragement and promotion of sport. The Club also performs the role of the Reserve Manager of Yarra Park.

There was no significant change in the nature of these activities during the period.

Results and Review of Operations

The consolidated net result of the Club amounted to a net profit of \$32.102 million compared with the prior year net profit of \$4.720 million.

During the 2023/24 financial year, more than four million patrons attended events held at the MCG for the second year in a row, which was a key driver to the exceptional financial result. The MCG hosted 48 AFL Home and Away matches plus six AFL Finals Series matches, with a total attendance of just under 3.3 million patrons, including the 2023 AFL Grand Final between the Collingwood Football Club and the Brisbane Lions, which saw the Magpies victorious in front of a stadium capacity crowd of 100,024. The summer of cricket featured Pakistan returning to the MCG for the Boxing Day Test, with a total attendance over four days of 164,835, with Australia winning by 79 runs.

The Club continues to attract major international sporting events, with Australia hosting New Zealand in Rugby Union's Bledisloe Cup in July in front of 83,944. In February 2024, three record-breaking nights saw a total of 288,000 fans witness the Taylor Swift | The Eras Tour light up the MCG. The three shows were the MCG's highest-selling concert series and highest-selling artist of all time.

Included in the 2024 financial year result is eight 2024 AFL Home & Away matches, which had a total cumulative attendance of 469,562.

Significant Changes in the State of Affairs

There have been no significant changes in the Club's state of affairs during the financial year.

Significant Events after Balance Date

There have been no significant events occurring after balance date which may affect either the Club's operations or results of those operations or the Club's state of affairs.

Likely Developments and Expected Results

The Committee does not expect any significant changes to the operations of the Club in the forthcoming financial year.

Environmental Regulation and Performance

The Club continues to display a positive commitment to the environment and recently became Australia's first sporting club to achieve Climate Active carbon neutral certification for business operations. This milestone recognises the Club's dedication to reducing our carbon footprint by minimising emissions in our daily operations and investing in carbon offset projects to balance the rest of our emissions. Achieving this certification reflects over a decade of sustainability efforts across various operational areas of the Club including energy use, waste management and water conservation.

Security

Given the MCG's status as an iconic event venue in Australia, the Club has placed high importance upon the management and mitigation of security risk issues. Accordingly, several strategic security management initiatives are ongoing. These measures have enhanced the safety of ground users on event and non-event days. The Committee and Club management will continue to develop, implement and assess security risk reduction strategies.

Safety

The Club is committed to prioritising a mentally healthy and a physically safe workplace for all staff, contractors and MCG tenants. This commitment also extends to our visitors and patrons who attend our venue.

This is supported by the successful implementation and ongoing improvement of our Health and Safety Management system which is certified to ISO45001:2018 and is reviewed regularly through reporting to the Committee and its Sub-Committees.

The Club also promotes work practices and behaviours that support positive mental health, by identifying, managing and where reasonably practicable eliminating or minimising psychosocial hazards and risks in the workplace.

Indemnification and Insurance of Committee Members

The Club has entered into Directors' and Officers' insurance policies and paid an insurance premium in respect of the insurance policies, covering members of the Committee, and the Directors, Executives and Statutory Officers of the Club. The Club have not included details of the nature of the liabilities covered or the amount of the premium paid in respect of the insurance contract, as such disclosure is prohibited under the terms of the contract.

Rounding

The financial report is presented in Australian dollars and all values are rounded to the nearest thousand dollars (\$'000) (where rounding is applicable) pursuant to the option available to the Club under ASIC Corporations Instrument 2016/191.

Discussion and Analysis:

Consolidated Statement of Comprehensive Income

Trends in Revenues and Expenditures

Income

Total consolidated income increased by \$36.541 million, from \$162.773 million in 2023 to \$199.314 million in 2024 (see note 3 for further details). The major items contributing to the increase in consolidated income were:

- Event related revenue increased \$14.251 million mainly due to increases in catering and gate revenue. More than four million patrons attended events held at the MCG for the second year in a row, which was a key driver to the exceptional financial result. The MCG hosted 48 AFL Home and Away matches plus six AFL Finals Series matches, with a total attendance of just under 3.3 million patrons. Included in the 2024 financial year result is eight 2024 AFL Home & Away matches, which had a total cumulative attendance of 469,562.
- Membership and Customer Services related revenue increased \$11.392 million due to a CPI increase in subscription values, along with no discount impact on subscription revenue from previous years.
- Commercial Operations revenue increased \$5.101 million mostly due to a once off payment received from a contracted agreement.
- Other income increased \$2.662 million mostly due to a once off payment from a contracted agreement.

Expenses

Total consolidated expenses increased by \$9.159 million, from \$158.053 million in 2023 to \$167.212 million in 2024. The key movements in material expense categories were:

- Events Administration expenditure which includes payments to AFL clubs increased \$3.444 million, in line with increased event related revenue.
- Members Contribution to the Gate expense which is paid to the AFL and Cricket Australia when members attend matches increased \$0.807 million in line with attendances and an additional two AFL Home & Away matches in the financial year.
- Combined administration and facilities expenditure increased \$4.225 million due to contractual arrangements increasing with CPI and increased activity from increased content during the year.
- Depreciation expense has increased \$1.116 million due to a large number of completed projects during the year.
- Finance costs decreased \$3.416 million due to the early repayment of debt.

Changes in the Composition of Assets and Liabilities

Consolidated Net Assets increased by \$32.102 million from \$354.001 million to \$386.103 million due to the net profit for the year.

Changes in Assets

The major changes were:

Current Assets

- Cash and Cash Equivalents increased by \$1.414 million as detailed in our Consolidated Statement of Cash Flows.
- Trade and Other Receivables increased by \$10.587 million due to increased catering income and the timing of payments received from major debtors.
- Held for trading financial assets increased by \$2.192 million due to additional investments made throughout the year and the improved market valuation at year end.

Non-Current Assets

- MCG Building Improvements decreased by \$25.640 million, due to the annual depreciation charges exceeding new capital expenditure for the financial year.
- Work in progress decreased by \$7.041 million due to a number of major projects being completed during the year, namely security upgrades, IT projects and refurbishment of hospitality areas.
- Plant and equipment increased by \$23.743 million due to capitalising major projects completed during the year, namely upgrades to turnstiles, security infrastructure, point of sale units, hospitality spaces and the Club's annual asset replacement program.

Changes in Liabilities

The major changes were:

Current Liabilities

 Income in advance increased \$9.180 million due to payments received from members in relation to their subscriptions and one contractual arrangement.

Borrowings

 Interest bearing liabilities decreased by \$37.032 million, due to a combination of scheduled payments and early debt repayments. At year end, the Club has repaid all debt relating to the Northern Stand redevelopment, more than two years in advance of the due date.

Changes in Cash Flows

There was a net increase in consolidated cash holdings during the year of \$1.414 million, with the Club reporting a closing cash position of \$23.516 million.

The major changes in cash flows were:

- Net cash flows from operating activities of \$58.200 million due primarily to the increase in net profit.
- Capital expenditure of \$25.991 million, namely upgrades to turnstiles, security infrastructure, point of sale units, hospitality spaces and the Club's annual asset replacement program.
- Full repayment of the loan held with Treasury Corporation Victoria during the financial year of \$37.032 million.

Notes to the Financial Statements

31 MARCH 2024

1. Basis of Preparation of Accounts of the Concise Financial Report

The consolidated concise financial report has been prepared in accordance with the requirements of Accounting Standard AASB 1039 Concise Financial Reports. The financial report is presented in Australian dollars.

The consolidated financial report of the Club has been prepared on a going concern basis. In assessing the issue of going concern the Committee has had regard to the financial position of the Club at year end, and approved cash flow and liquidity forecasts and other relevant information for the 12 months subsequent to the approval of this financial report.

The Club has applied the following standards and amendments for the first time in their annual reporting period commencing 1 April 2023:

- AASB 17 Insurance Contracts
- AASB 2023-2 Amendments to Australian Accounting Standards -Definition of Accounting Estimates
- AASB 2021-2 Amendments to
 Australian Accounting Standards Disclosure of Accounting Policies
 Definition of Accounting Estimates
 [AASB 7, AASB 101, AASB 108, AASB 134
 & AASB Practice Statement 2].

The amendments listed above did not have any impact on the amounts recognised in prior periods and are not expected to significantly affect the current or future periods.

2. Summary of Significant Accounting Policies

(a) Basis of consolidation

The consolidated financial statements are those of the consolidated entity, comprising the Club, the Australian Sports Museum Limited ("ASM") and Melbourne Cricket Club Sports Limited ("Sports") (controlled entities). The ultimate parent is the Club.

The Club has determined it controls the ASM and Sports. The principal activities of the ASM are the operation of a sports museum at the MCG. Amounts relating to the construction and fit out of ASM are recorded in the Club's financial report as they are considered part of the MCG.

The principal activities of Sports is management responsibility of the

Club's sporting fields and venues across Melbourne which are utilised by the community and by the MCC sporting sections. The 13 MCC sporting sections are not consolidated, as these entities are separately managed incorporated associations with independent Committees who have entered into an affiliation agreement with the Club.

The Melbourne Cricket Club Foundation Limited ("Foundation"), a company limited by guarantee, is categorised as a director related entity and is not consolidated into the Club's accounts, on the basis that the Club does not control the Foundation based on relevant Accounting Standard criteria.

In preparing the consolidated financial statements, all intergroup balances and transactions, income and expenses and profit and losses resulting from intra-group transactions have been eliminated in full.

The controlled entities are fully consolidated from the date on which control is transferred and cease to be consolidated from the date on which control is transferred out of the consolidated Group.

(b) Yarra Park

Effective 15 March 2010, the Melbourne Cricket Ground and Yarra Park Amendment Act 2009 ("Yarra Park Amendment Act") appointed the Melbourne Cricket Ground Trust ("MCG Trust") as the Committee of Management for Yarra Park, thereby expanding the functions of the MCG Trust and specifying the management arrangements and the implementation of an improvement plan for Yarra Park.

Under the Yarra Park Amendment Act, the MCG Trust assumed responsibility for car parking arrangements, receiving advice from the Yarra Park Advisory Committee on the operation and management of Yarra Park, and the management of licences and contracts. Further, any money received by or on behalf of the MCG Trust in relation to Yarra Park may only be spent on the operation, management, maintenance and improvement of Yarra Park, and such monies received and spent must be separately accounted for in the financial report.

The Yarra Park Amendment Act allowed the MCG Trust to delegate its functions and responsibilities for Yarra Park to the Club and it has done so via the execution by the MCG Trust, the Club and the relevant Ministers of the State Government of Victoria through a formal Instrument of Delegation and Second Deed of Amendment to the MCG Management and Indemnity Deed. These agreements appoint and allow the Club to fulfil all of the responsibilities assigned to the MCG Trust under the Yarra Park Amendment Act as the Reserve Manager of Yarra Park.

The Club has agreed a separate accounting policy with the MCG Trust that details those revenue and expense items that are received or incurred by the Club in the performance of their role as the Reserve Manager of Yarra Park. These amounts are included in the totals in the Statement of Comprehensive Income of the Club.

The net (deficit) of these identified items is then transferred to a separate reserve as a sub-component of equity so that these amounts can be identified and spent on the operation, management, maintenance and improvement of Yarra Park.

The Club has also recorded a number of Yarra Park plant and equipment assets that were contributed by the MCG Trust for nil consideration.

(c) Significant accounting judgements, estimates and assumptions

Other than those listed below, the Club's accounting policies do not contain significant accounting judgements or significant accounting estimates and assumptions that would have a significant risk of causing a material adjustment to the carrying amounts of certain assets and liabilities within the next annual reporting period.

Key accounting judgement and estimates made by management include; the Basis of Consolidation, the ASM collection which is carried at fair value, the determination of appropriate depreciation periods, the useful life of assets, and the incremental borrowing rate used in the measurement of lease liabilities in accordance with AASB 16

(i) Transactions with other related parties

a) MCG Trust

The Club is party to a "Deed of Variation of Lease" with the MCG Trust. The Club's tenancy of the MCG runs until 31 October 2059 with an option to extend its lease over the members' reserve for a further 25 years. In 2023 the Club's existing tenancy of the MCG was extended until 31 October 2059.

Under a separate management agreement with the MCG Trust and the State of Victoria, the Club's role as ground manager of the MCG also runs until 31 October 2059.

During the year, the Club paid the MCG Trust \$5.425 million (2023: \$5.080 million) in respect of its lease rental of the MCG.

The MCG Trust distributed \$5.000 million to the Club for the repayment of term loans (2023: \$4.650 million).

The MCG Trust has delegated its functions and responsibilities for the management of Yarra Park to the Club. It has done so via the execution by the MCG Trust, the Club and the relevant State Government of Victoria Ministers through a formal Instrument of Delegation and Second Deed of Amendment to the MCG Management and Indemnity Deed. These agreements appoint and allow the Club to fulfil all of the responsibilities assigned to the MCG Trust under the Yarra Park Amendment Act as the Reserve Manager of Yarra Park.

b) Australian Sports Museum Limited

From time to time, the Club undertakes transactions on behalf of ASM. As at year-end, amounts receivable by the Club from ASM were \$0.094 million (2023: \$0.582 million). Amounts payable by the Club to ASM were nil (2023: nil). Any amounts owing between the Club and ASM are settled on 30 day terms and are non-interest bearing. These amounts are eliminated in the consolidated financial report.

c) Melbourne Cricket Club Sports Limited

From time to time, the Club undertakes transactions on behalf of Melbourne Cricket Club Sports Limited. As at yearend, amounts receivable by the Club from Sports were nil (2023: nil). Amounts payable by the Club to Sports were nil (2023: nil). Any amounts owing between the Club and Sports are settled on 30 day terms and are non-interest bearing. These amounts are eliminated in the consolidated financial report.

d) Key Management Personnel

Key management personnel are determined to be the Chief Executive Officer and General Managers of the Club. During the year, total annual remuneration of \$3.404 million (2023: \$3.079 million) was earned by key management personnel for services provided to the Club.

(ii) Transactions with director-related entities

The MCC Foundation is a director related entity of the Club. During the year, the Club remitted to the Foundation \$12.055 million (2023: \$12.392 million) pursuant with the provisions of the amended Indemnity Deed between the MCG Trust and the Club, for the purposes of promoting and encouraging sport and managing the MCC Museum and Library.

From time to time, the Club undertakes transactions on behalf of the MCC Foundation. As at year-end, net amounts receivable by the Club from the MCC Foundation were \$0.121 million (2023: \$0.410 million). Net amounts receivable by ASM from the MCC Foundation at year end were \$0.002 million (2023: nil). Net amounts receivable by Sports from the MCC Foundation at year end were nil. (2023: \$0.011 million).

During the current year, no sporting facility assets were transferred from the MCC Foundation to Sports in the form of a capital contribution (2023: \$0.011 million), which represented the book value of the assets at the time of transfer.
