#### MELBOURNE CRICKET CLUB

#### MCC PLUS CARD SPEND AND WIN PROMOTION (MONTHLY AND YEARLY)

#### **RECITALS**

- (A) The MCC has introduced an MCC Plus Card allowing members to purchase items at the MCG with their membership cards.
- (B) The MCC intends to conduct a "Spend and Win" Promotion for its MCC Plus Card [the **Promotion**].
- (C) There will be monthly Promotions and a yearly Promotion.
- (D) Key details for the Promotion are contained in the Reference Schedule.

#### **TERMS AND CONDITIONS**

- Information on how to enter, the draw and prize details form part of these terms and conditions [Terms and Conditions]. Entry into the Promotion is deemed acceptance of these Terms and Conditions.

#### Who can enter
